Terms and Conditions

Updated as of January 1, 2022

These Terms and Conditions (these "Terms") apply to all Ventre's Adventures tours (each a "Tour") departing after January 1, 2022 and are subject to change without notice. The Terms in effect at the time of departure of your Tour will apply.

What's included in the Program Price?

- \$500 non-refundable deposit
- Round-trip airfare
- Travel IQ Insurance
- Accommodations in hotels with bathrooms
- A Tour Director available 24 hours a day when you arrive until you depart.
- Breakfast daily (lunch and dinner differ on location)
- Sightseeing tours and excursions led by licensed local guides
- Airport transfers
- Transportation to all included activities
- Entrance fees as specified
- Cruises, trains, or ferries as specified
- Photographer

The above apply to all Tours unless otherwise noted on the Tour itinerary.

What's not included in the price?

- Optional excursions
- Some lunches and dinners (vary on location)
- Transportation to free-time activities
- Customary gratuities (for bus drivers and local guides)

- Porterage
- Any applicable baggage-handling fees imposed by the airlines
- Expenses caused by airline rescheduling, cancellations, or delays caused by the airlines, bad weather, or events beyond Ventre's Adventures' control.
- Passport, visa, and reciprocity fees.
- Trip cancellation insurance

Enrollment

In order to book a Tour with Ventre's Adventures you must submit an Enrollment Form according to the terms below. All Enrollment Forms must be received by Ventre's Adventures 200 days prior to departure. Travelers must provide complete first, middle, and last names, and dates of birth exactly as they will appear on their passport.

Name Correction

Any corrections needed to match submitted names to passports made after 200 days prior to departure will require that Ventre's Adventures change the applicable Traveler's flight reservation, resulting in a \$200 minimum fee per airline, up to the cost of a new published fare ticket. This may also result in a different flight itinerary from the entire group. Travelers who have not yet applied for a passport must provide their full name and date of birth as they appear on their birth certificate.

<u>Waitlist</u>

At the discretion of the Tour Director, a waitlist may be offered for fully booked Tours. The \$500 non-refundable deposit is required for waitlist enrollments. If space becomes available on the Tour and the applicant chooses to enroll, the Payment Plan Policies and Cancellation Policy described herein apply immediately. If space does not become available 30 days prior to departure or if the waitlist enrollee cancels its enrollment in the waitlist, the \$500 deposit will be refunded.

Adult Enrollment

We welcome adults (those age 20 and older) on Tours. The Program Price for an adult will increase from the minor Program Price due to increased rooming, costs, which will be determined by Ventre's Adventures.

Passport And Visas

Each Traveler must obtain a passport and any applicable visas or other travel documents prior to departure. For certain Tours, Travelers must submit travel documents to Ventre's Adventures no less than 200 days prior to departure. If a Traveler is unable to obtain these travel documents, the Cancellation Policy will apply. Please be sure that passports are valid for at least 6 months after the Tour ends. Many countries, including the US prohibit entry and/ or exit from the country for an individual whose passport will expire within 6 months of such entry or exit. Ventre's Adventures will not be responsible for and Traveler shall bear any and all expenses incurred by a

Traveler who is denied entry or exit from a country due to an expiring passport. Non- US citizens will need to contact the embassy or consulate of their destination countries to ensure they meet specific entry requirements. Ventre's Adventures will not be responsible for and Traveler shall bear any and all expenses incurred by a Traveler who is denied entry or exit from a country due to specific entry or exit requirements applicable to non-US citizens.

Travel Protection

Travelers can help protect their investment from the unexpected by purchasing a trip cancellation policy. Ventre's Adventures does not provide trip cancellation insurance, nor does cancellation insurance guarantee a full refund. Please note that trip cancellation policies may not cover cancellations due to complications with COVID-19.

Flight Information

Upgrades, stopovers, or the use of frequent flier miles to book airfare for a Tour are not allowed.

Do I have to travel on all legs of my flight itinerary?

You must travel on all legs of your itinerary. If you do not travel on a portion of your flights, the remaining portions will be canceled. You will be responsible for purchasing a new ticket as well as for any service fees charged by the airlines.

What happens if my flight is delayed? Ventre's Adventures is not responsible for delays or other changes made by airlines, including, without limitation, schedule changes or mechanical, weather, or capacity-related delays.

Rooming

Ventre's Adventures handles final rooming assignments for all Travelers.

<u>How are minor Travelers roomed?</u> Travelers will room in doubles, triples, or quads with others of the same sex from the entire Tour group. This means that Travelers from different schools may room together.

<u>How are adult Travelers roomed?</u> Adults are placed in twin accommodations, which can sometimes result in an increase in the applicable Program Price. Adult Travelers can also request a single room, but will be responsible for the increase in the applicable Program Price.

Miscellaneous

What about lost belongings? Ventre's Adventures is not responsible for the loss of passports, airline tickets, or other documents, or loss of or damage to luggage or any other belongings. In the case of a lost passport or visa, the Traveler is responsible for all fees and payments including but not limited to: transportation, accommodation, and paperwork, and will be billed accordingly.

What about food allergies?

We recognize that some Travelers have severe food allergies. We will do our best to ensure that our vendors are informed of the situation, but we cannot guarantee that all requests will be accommodated.

What about vaccinations?

Ventre's Adventures follows the guidelines set forth by the Centers for Disease Control. All Travelers must comply with the mandatory vaccination requests set forth by the Centers for Disease Control. Failure to do so and/or provide documentation or confirmation of vaccinations prior to departure will result in cancellation of the Traveler's booking in accordance with the Cancellation Policy.

What items are prohibited from the Tour?

For the safety and wellbeing of all Travelers, no firearms or any other weapons are permitted on the Tour except as required by law.

Payment Plan Terms and Conditions

Should you choose to enroll in the automatic payment plan, the following terms and conditions shall apply.

Travelers must select a payment method from an approved credit card as listed on the website.

Travelers must provide correct billing information, and pay the Tour's \$500 nonrefundable deposit before the Automatic Payment Plan is activated.

The credit card will be charged equal, monthly installments on scheduled payment dates until the total Program Price, including any applicable additional fees, is paid in full. Due to weekends and holidays, Ventre's Adventures reserves the right to debit the Travelers' credit card up to three days before or after any scheduled payment date.

All additional items not included in the Automatic Payment Plan, including any Tour optional purchases or add-ons, or any fees, will be due at the time of departure. A non-refundable fee of \$40 will be assessed each time a payment is returned or declined. Ventre's Adventures reserves the right to cancel a Traveler's Tour booking in the event of returns or declines in any two attempted payments, in which case the Cancellation Policy will apply.

A \$10 processing fee will apply to each monthly payment, in addition to the Program Price.

Cancellation Policy

Cancellation or Modification by Ventre's Adventures

Ventre's Adventures retains the right to cancel, modify, or delay the Tour as a result of unforeseeable events that are beyond Ventre's Adventures' reasonable control, including but not limited to: acts of God, war (whether declared or undeclared), terrorist activities or threats of terrorist activities, instability in a destination country, incidents of violence, epidemics, pandemics, public health issues or quarantine or threats of public health issues, substantial currency fluctuations, strikes, government restrictions, fire or severe weather conditions, or any other reason that makes it inadvisable, impossible, or commercially unreasonable in the sole opinion of Ventre's Adventures to conduct the Tour as originally planned.

In addition to the foregoing, Ventre's Adventures specifically retains the right to cancel, modify, or delay the Tour as a result of any laws, ordinances, rules, or restrictions, whether national, local, or municipal in nature which are put in place in response to the ongoing

worldwide pandemic due to the novel coronavirus, COVID-19, ("COVID-19") or otherwise to address public health emergencies, epidemics, or pandemics (collectively "Health Safety Restrictions") which prevent the conduct of the Tour or materially negatively impact all or a portion of the Tour, notwithstanding the knowledge of the parties of the ongoing pandemic at the time of booking. Health Safety Restrictions shall include, without limitation, quarantines, stay at home orders, restrictions on travel, social distancing requirements, and facility occupancy restrictions.

If Ventre's Adventures cancels the Tour for any such reason, Travelers will receive a full refund of the Program Price except for any amounts incurred by Ventre's Adventures which are nonrefundable or non-cancelable.

Cancellation by Traveler

The cancellation policies outlined below take into consideration the costs Ventre's Adventures incurs long before a Tour departs. Notice of cancellation of a Traveler's booking from a Ventre's Adventures Tour will only be effective if made by a Traveler over the age of 18 or a minor Traveler's legal guardian. The date of cancelation will be determined by the date on which Ventre's Adventures receives notice. Traveler cancellations due to trip postponement will follow the cancellation policy detailed below with the original departure date, not the postponed departure date.

Deadlines relating to Cancellation Policy If a Traveler's notice of cancellation is received by Ventre's Adventures: 180 days or more prior to departure: full refund except the \$500 non-refundable deposit, all non-refundable fees including flights and group restructuring fee, and a \$200 cancellation fee.

179 to 110 days to departure: full refund except the \$500 non-refundable deposit, all non-refundable fees including flights and group restructuring fee, and a \$400 cancellation fee.

109 to 45 days prior to departure: full refund except the \$500 non-refundable deposit, all non-refundable fees including flights and group restructuring fee, and a cancellation fee equal to 50% of the program price

44 days or less prior to departure: no refund will be issued.

The parties acknowledge and agree that Ventre's Adventures will incur damages in the event of a cancellation, which damages will be hard to foresee or measure and that the fees described above are a reasonable and agreed upon estimate thereof.

Cancellations relating to COVID-19

All Travelers must provide Ventre's Adventures with a negative COVID-19 test result for such Traveler prior to the Tour departure. If Traveler does not do so, Ventre's Adventures will cancel the Traveler's Tour booking, in which case the Cancellation Policy will apply.

If, within three weeks of the applicable Tour departure date, a Traveler tests positive for COVID-19, the Traveler's booking will be cancelled unless the Traveler subsequently provides Ventre's Adventures with a negative COVID-19 test result prior the Tour departure date, in which case the Cancellation Policy will apply.

WHEN YOU ENROLL ON YOUR TOUR

In order to enroll in a Tour, you agree these Terms, including the rules and regulations set forth below. If you do not comply with these Terms or any specific rules set by the Tour Director or Ventre's Adventures personnel, Ventre's Adventures may, in its sole discretion, dismiss you from the Tour. In the event of such dismissal you will be responsible for returning home at your own expense with no refund for the missed Tour portion. Decisions regarding Tour dismissal will be made by Ventre's Adventures at their sole and absolute discretion.

Rules and Regulations

All Travelers must adhere to the following regulations while on a Tour:

1. All scheduled activities are obligatory. If you are sick or have a physical ailment that might prevent you from participating in an activity, you must tell Ventre's Adventures personnel in advance.

2. Any plans that a Traveler desires to make on a Tour, outside of the Tour activities planned by Ventre's Adventure, including, without limitation, plans to visit friends or relatives in a destination country, you must inform Ventre's Adventures of such request before the Tour begins and receive permission from Ventre's Adventures prior to engaging in any plans outside of the Tour activities. You must complete the Tour Leave Form to receive permission for any plans outside of the Tour activities.

3. All Travelers must adhere to any nightly curfew that Ventre's Adventures may set, such curfews are set for your own safety and security. Room checks will be conducted at the discretion of Ventre's Adventures. Visitors or group members of the opposite sex are not permitted in your room.

4. Smoking is not allowed on buses, during meals, in hotel rooms, or in any other shared, enclosed space.

5. Hitchhiking and the driving or renting of any motor vehicle is strictly forbidden for all Travelers.

6. You are required to pay for any phone calls or additional expenses incurred at hotels. These expenses must be paid the evening before departure at each hotel.

7. Travelers under the age of 18 may not consume alcohol on Tour. Travelers over the age of 18 (or older, if local laws require) may consume beer or wine in moderation. Ventre's Adventures personnel and/or parents may prohibit all alcohol consumption at their discretion. Excessive drinking by any Traveler will not be tolerated and will result in dismissal from Tour at the Traveler's own expense.

8. Illegal activities (including the use of illegal drugs) will not be tolerated and are punishable by immediate dismissal from the Tour. If you are involved in any illegal activities, all costs to return home are at your own expense. If the local

authorities are involved, you will be subject to the laws of the country you are visiting.

9. Payment for damage done to hotel rooms, at any location on the Tour, or to buses is your responsibility. If you notice any damage upon arrival you should notify Ventre's Adventures immediately.

10. Travelers must at all times comply with all posted signs and all instructions from the Tour Director, Ventre's Adventures personnel or third party partners of Ventre's Adventures whether related to facility or location operations, rules, procedures, health and safety requirements, or otherwise. Specifically you must follow all rules, guidelines, requirements and laws relating to COVID-19 whether set out by Ventre's Adventures, third party partners of Ventre's Adventures, or local, state, or national governments including but not limited to mask mandates, temperature checks, social distancing, and COVID-19 testing.

11. You are required to pay for any additional fees and expenses for Ventre's Adventures personnel and your traveler should your traveler create a scenario to extend his or her trip. Such scenarios include, but are not limited to, illness, positive COVID test result, lost passport, etc.
